

BIOS SPEAKERS



Charlotte Isaksson currently works as the Senior Gender Advisor at the European External Action Service (EEAS) in Brussels. Previously she was the Gender Advisor (GENAD) within Allied Command Operations, NATO at SHAPE in Belgium between 2011-2016. She served earlier as GENAD within the Directorate of Operations at the Swedish Armed Forces Headquarters as well as prior positions within the Ministry of Defence primarily in the fields of gender and global, regional, national and individual security. Her main work has been focusing on Security, Gender Equality and Integration of Gender Perspectives – including UNSCR 1325 on Women, Peace and Security and related resolutions on Conflict related Sexual Violence.

Aíne Hearns joined the Irish Department of Foreign Affairs and Trade in 1979 and is currently the Director of the Conflict Resolution Unit with responsibility for Ireland's National Action Plan on UNSCR 1325 (Women Peace and Security).
