68.5% closed




The gender gap is narrowing, but the collective rate of progress has slowed down. Without a bold push forward, it will take 134 years to reach full parity.

SDG Gender Index 2024

Not one country is on track to achieve gender equality by 2030. Nearly 40% of countries have stagnated - or even declined - between 2019 and 2022. 74% of the SDG targets won't be achieved without gender equality.



If past trends continue, the world won't achieve gender equality until 2121. How is the Netherlands performing on gender equality in the SDGs?

The 2024 SDG Gender Index covers 139 countries, 96% of the world's girls and women, and 14 of the 17 Sustainable Development Goals. It includes 56 indicators capturing gender-related measures across the 2030 Agenda.

PROGRESS ON THE SUSTAINABLE DEVELOPMENT GOALS THE GENDER SNAPSHOT 2024

- None of the indicators and sub-indicators of Sustainable Development Goal 5—the goal for gender equality—are being met
- No country has all relevant laws to prohibit discrimination, prevent gender-based violence, uphold equal rights in marriage and divorce, guarantee equal pay, and provide full access to sexual and reproductive health
- It will still take 137 years to lift all women and girls out of poverty
- The annual global cost of countries failing to adequately educate young populations is over USD 10 trillion



Outlook for gender equality

- Very little progress over the past years
- Multiple crises, affecting women and girls disproportionately and deepening existing inequalities
- Mis- and disinformation, rising anti-gender movement, erosion of liberal democracies and international declarations, shrinking civic space
- 'Super-election-year': stress test for women's participation and representation and outlook for women and girls



Review of civil society recommendations

Recommendations CSW65-68, NGO Review Report Beijing+20, recommendations Beijing+20 and Beijing+25, most recent CEDAW and GREVIO shadow reports

- Ensure and facilitate meaningful and effective participation and representation in decision-making
- Eliminate gender-based violence and discrimination
- Implement an intersectional, gendertransformative and inclusive approach
- Invest in intersectional gender-disaggregated data, analyses and reporting
- Combat gender stereotypes and gender bias

Ideas for recommendations & two-pager

- Positive framing
- Focussing on the benefits
- Call to action



- From paper to practice:
 - Effective and sustainable implementation BPfA. Intersectional and inclusive, shared responsibility, active role men and boys.
- From gender neutral to gendertransformative:
 - Gendermainstreaming, monitoring, evaluation and accountability
 - Including gender sensitive indicators, data and statistics
- From fixing the women to fixing the system
 - Addressing root causes, combating stereotypes, power and dependency relations, discrimination and undervaluation of (the contribution of) women and girls

- From thinking in costs to benefits
 - Investing in gender equality = investing in a more sustainable, fair and healthy world. This contributes to the economy, prosperity and well-being of society.
 - Sustainable, long-term financing for gender equality and WHR organisations.
 - Gender responsive planning and budgeting.
- From stagnation (and backsliding) to progress
 - Actively combating mis- and disinformation, genderbased violence and discrimination, advancing SRHR, education, emerging issues
